RoHS II & Directive 2017/2102 amending Directive 2011/65/EU

Subject;

The restriction of the use of certain hazardous substances in electrical and electronic equipment.

"RoHS II" Directive 2011/65/EU restricts the use of certain substances in electrical and electronic equipment (EEE). It has replaced the old RoHS 2002/95/EC since 2013.

European Directive 2015/863/EU added total of 4 new articles to RoHS Annex II. These new restrictions took effect on July 19, 2019. Annex – II (with Commission Delegated Directive (EU)2015/863 of 31 March 2015):

- **Lead (Pb)** < 1000 ppm
- **Mercury** (**Hg**) < 1000 ppm
- **Cadmium (Cd)** < 100 ppm
- HexavalentChromium(CrVI) < 1000 ppm
- PolybrominatedBiphenyls(PBB) < 1000 ppm
- PolybrominatedDiphenylEthers(PBDE) < 1000 ppm

Additional Substances introduced by (EU)2015/863:

- Bis(2-Ethylhexyl)phthalate(DEHP) < 1000 ppm
- Benzylbutylphthalate(BBP) < 1000 ppm
- **Dibutylphthalate(DBP)** < 1000 ppm
- Diisobutylphthalate (DIBP) < 1000 ppm
